Why this conference:

The Lisbon Treaty has entered into force on 1 December 2009. One year after, it is time for an assessment of the main implications and challenges of what has been defined without doubt a major achievement and a crucial step in the European integration process.

This conference brings together political scientists, legal scholars as well as experts and practitioners, who will discuss the impact of the new treaty on the theories of EU integration, the decision-making processes and the policies of the Union, with a specific focus on some of the most notable changes, such as the European External Action Service, the Citizens Initiative and the role of the European Parliament in the new architecture of the Union. Within this framework, a special attention will be given to the way in which the new treaty impacts, externally, on the transatlantic relationship and, internally, on the “democratic deficit” of the Union, with the aim to shed light on the potential of the Lisbon Treaty to strengthen the EU as a foreign policy actor, and to tackle some of the highly debated weaknesses of the European insitutional setting.

The cooperation between the Centro d'Eccellenza Europeo Jean Monnet of the Univeristy of Florence and The Master in European Union Policy Studies by James Madison University has the aim of spreading high level knowledge of the EU and to put in touch scholars, practitioners and theorists, bringing them closer to the students of both Italian and foreign universities in Florence.
